



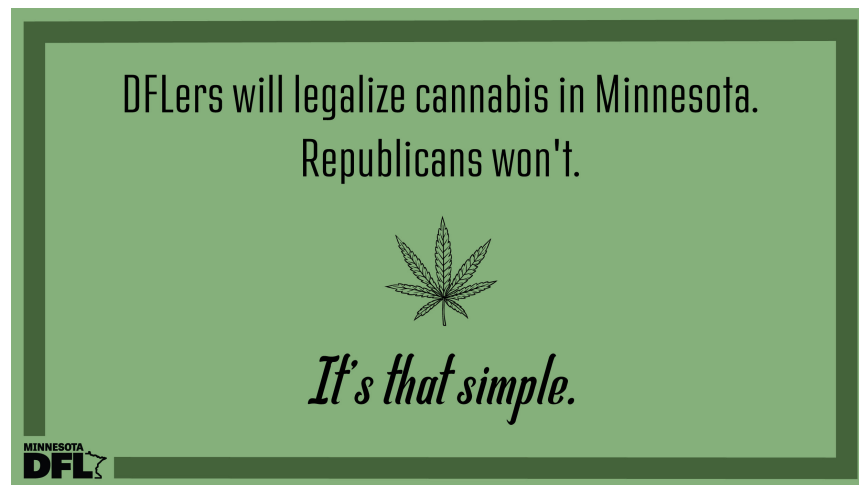
Legalization and decriminalization of marijuana is an official part of the DFL platform. If elected in majorities this fall, they WILL legalize adult-use cannabis.

As of Friday, July 1, 2022, the sale and purchase of edibles and beverages that contain up to 5 milligrams of tetrahydrocannabinol (THC) per serving and 50 milligrams per package is legal for adults in Minnesota age 21 and older.

This is a first step to decriminalizing and legalizing adult-use cannabis. But it's only a first step. A DFL majority and reelecting Governor Walz can do so much more for Minnesotans.

The Minnesota House already approved a bill last year legalizing adult-use cannabis for adults and Gov. Walz supports it. The only thing standing in the way is the Minnesota Senate Republican majority. Minnesotans can make a huge difference at the polls this fall to see the policy changes they and DFLers want! Electing wide DFL majorities to the state legislature and reelecting Gov. Walz is the answer.
